

# Military Child Care in Your Neighborhood (MCCYN) DoD Parent Fees

This handout provides the Total Family Income (TFI) Category definitions, the DoD monthly parent fees for full-time and part-time care, the provider rate cap for each, and the list of high cost installations for FY 23.

#### **Total Family Income Categories**

The family's annual TFI determines the TFI Category.

MCCYN is available to National Reconnaissance Office sponsors who have a TFI less than or equal to the cap of level IV of the Executive Schedule.

#### **Full-time Monthly DoD Parent Fees\***

Families are responsible for the monthly parent fee which is based on their TFI Category and whether the sponsor's assigned installation is in a high cost area. The provider rate cap effective 1 November 2022 for fees charged for full-time care is \$1,700 per month. Families are responsible for their monthly DoD parent fee **plus** any additional cost if their provider charges more than \$1,700 per month.

The provider rate cap effective 1 November 2022 for fees charged for part-time is \$850 per month. Families are responsible for their monthly DoD parent fee **plus** any additional cost if their provider charges more than \$850 per month.
